

# St. John Ambulance - Customer Service Policy - National Accounts

### Withdrawals:

Withdrawals from one/two-day classes, are charged a \$40 fee (subject to applicable taxes) for a withdrawal request received between 2 and 5 business days prior to the scheduled class date. No fee will be charged on withdrawal requests received more than 5 business days prior to the scheduled class date. For withdrawal requests received less than 2 business days prior to the scheduled class date, the full registration fee will be charged.

#### **Transfers:**

Transfer requests for one/two-day courses, are subject to a \$25 fee (subject to applicable taxes) if requested within 5 business days of the scheduled class start date, unless otherwise legislated by Provincial Regulators.

#### **Cancellations:**

- St. John Ambulance reserves the right to cancel classes that do not reach the minimum enrollment requirements or for extenuating circumstances. Every effort will be made to notify all registrants in a timely manner prior to the class start date. The affected student will be rescheduled to another class without a fee.
- In extenuating circumstances, a refund may be considered.

## No Shows:

No show registrations will be charged the full registration fee.

## **Private Classes:**

- Private classes, which the client cancels more than 15 business days prior to the scheduled start date, will be subject to a \$40 administration fee (subject to applicable taxes).
- If the cancellation of the class is requested within 15 business days of the scheduled start date, 50% of the cost of training (based on the minimum number of students required) and any additional non-refundable fees (i.e., accommodations, flights, travel, etc.) will be charged.

# Occupational First Aid Level 2/3:

Requests for transfer or cancellation/refund must be received five (5) full business days prior to the scheduled start date of the class or the course fee will be forfeited. A \$150.00 service fee will be charged for all changes.

### Occupational First Aid Level 2/3 re-exams:

- When a student is unsuccessful, a fee of \$25.00 will be charged for the written re-exam and/or a fee of \$100.00 will be charged for the practical re-exam.
- Requests for any transfer or withdrawal requests received less than 2 business days prior to the scheduled class date, the full registration fee will be charged.

#### Late:

Students are expected to arrive on time.

### **Blended Courses:**

- For all Blended Courses, the student must complete the online portion of the program prior to the start of the in-class part of the training.
- No withdrawals are permitted for the Mental Health Commission of Canada Mental Health First Aid course
- No withdrawals from blended first aid courses are permitted once access is given to the online portion of the class. For a \$25 fee (subject to applicable taxes), Companies may substitute one class member for another so long as the student can complete the online portion of the program prior to the start of the in-class part of the training.
- In class transfers within the same course are permitted if requested more than five (5) days from the start of the classroom training. Between 2 to 5 days prior to the start of the classroom training, transfers will be permitted subject to a \$25 fee (subject to applicable taxes). No transfers will be permitted within 2 days of the start of the classroom training.

A charge of \$15.00 (plus applicable taxes) will be charged on any certificate(digital/paper) reprint requested by client.
